- 10 AM – 12:00 PM – **Proposed Efforts and Initiatives of the Non-Profit Funder - Research Institution Partnership-**  
*Metropolitan Ballroom*

At the October 2017 COGR meeting a panel of non-profit funder and research institution representatives discussed an ongoing and growing partnership aimed at facilitating academic research funded by nonprofit organizations. As the Nonprofit Funder – Research Institution (NFRI) Partnership plans its third major meeting, university representatives leading efforts in the areas of intellectual property and technology transfer, research project support costs (aka F&A) and streamlining administrative processes will discuss current initiatives and seek your feedback on proposed efforts and next steps.

Dr. Droegemeier was confirmed earlier this year as Director of the Office of Science and Technology Policy. He served for many years as Vice President for Research at the University of Oklahoma, and is a renowned meteorologist specializing in severe weather events. He has also served on the National Science Board, including as Vice Chair. Dr. Droegemeier has long been active in COGR, serving on the Board from 2009 to 2014. We are pleased to welcome him back to COGR to discuss his thoughts on and vision for science under the current administration.

- 2:00 PM – 3:15 PM – **Federal Agency Efforts to Address Foreign Influence on Research and Intellectual Property**  
*Metropolitan Ballroom*

Members of Congress, the administration, and security and research funding agencies have expressed concern about state-sponsored programs to improperly access or replicate U.S. federally funded research data and information, including proposed research, to gain competitive advantage. Dr. Michael Lauer, Deputy Director for Extramural Research, National Institutes of Health, will join us to discuss agency concerns expressed in an August 20 letter to grantees, recommendations from the Advisory Committee to the Director Working Group on Foreign Influences on Research Integrity's December 2018 report, and steps NIH is taking to address concerns and recommendations. Rebecca Kaiser, Head of the Office of International Science and Engineering at the National Science Foundation, will provide an update on NSF activity related to foreign influence. Thomas (T.L.) Cabbage III, Deputy Under Secretary for Science, Department of Energy, will discuss DOE's Foreign Talent Program Policy which "mandates that DOE federal and contractor personnel fully disclose and, as necessary, terminate affiliations with foreign government-supported talent recruitment programs" and other activities to address foreign influence.

- 3:30 PM – 4:30 PM – **Federal Agency Report on Reducing Administrative Burden in Animal Research** *Metropolitan Ballroom*

The NIH Office of Laboratory Animal Welfare (OLAW), U.S. Department of Agriculture (USDA), and Food and Drug Administration (FDA) issued a draft report, Reducing Administrative Burden for Researchers: Animal Care and Use in Research, for comment on December 7, 2018. The report follows a review by federal agencies to ensure that regulations and policies associated with research involving laboratory animals are not inconsistent, overlapping, or unnecessarily duplicative and to improve the coordination of agency regulations and policies as directed by the 21st Century Cures Act. As part of their review, agency representatives conducted a series of listening sessions and published a request for information in March 2018. Dr. Pat Brown, Director, NIH OLAW, Bernadette Juarez, Deputy Administrator, USDA Animal Care Program, and Dr. Brianna Skinner, Senior Regulatory Veterinarian, FDA, will join us to discuss the report and next steps in reform efforts.

Sara Barber, Legislative staff of Ranking Member Eddie Bernice Johnson (D-TX) and [Chairwoman](#) of the House Science Space, and Technology Committee will discuss Ms. Johnson’s Bill [H.R. 36](#) entitled “Combating Sexual Harassment in Science Act of 2019.” H.R. 36 would expand research efforts through funding grants to better understand the causes and consequences of sexual harassment affecting individuals, students, and trainees in STEM programs. This session will present an opportunity for COGR members to ask questions about the reporting requirements of the bill including publishing on publicly available internet websites the aggregate results of assessments regarding findings or determinations of sexual harassment, the requirement to make public on an annual basis the number of reports of sexual harassment, etc. Joanne Carney, Director, Office of Government Relations, AAAS will discuss sexual harassment from the scientific community perspective. This will include a discussion of a new multi-society project along with the specific actions/policies undertaken at AAAS.
