SUBJECT: COGR Facilities and Administrative Cost Rates Survey for 1999-2000

Enclosed are the results of the COGR Facilities and Administrative Cost Rates Survey for 1999-2000. Included with it is summary information for the years 1995-1999. The compilation is provided in hard copy, and the 1999-2000 information is also provided on a diskette in three different formats; Lotus, Excel, and QuattroPro.

This compilation displays individual components of both proposed and negotiated facilities and administrative cost rates. It also includes, among other data, percentages of carryforward, type and applicability of rate, cognizant agency, institutional operating expenses, research volume and universities that are reporting the use of special cost analysis studies. This year for the first time the report contains data on space for the principal institutional functions, as well as rates negotiated for future years. We also include data on the federal portion of the MTDC base, and facilities and administrative cost recovery from federal awards.

The compilation does not include information on the rationale for including certain costs in one pool as opposed to another, nor does it explain different cost allocation methodologies, which might be used in one university or another. Comparison of rates without knowledge of these differences is discouraged.

In a few cases universities have been unable to provide a full breakdown of negotiated rates into components. In such cases blank values appear in the corresponding columns. Zero values in general indicate that a particular component was proposed, but not included and/or separately identified in the negotiated rate.

For the past several years, Dr. Marvin Ebel has conducted the data collection, entry and analysis on behalf of COGR. His professional expertise and his careful management of this project have provided an invaluable service to the university membership. We extend our profound gratitude.

The project will continue as an in-house operation and I look forward to your continuing cooperation. The questionnaire soliciting 2000-2001 data will be mailed to you under separate cover next year. I would appreciate your prompt attention to it when it arrives. If you have suggestions for changes or additions to the new survey, please contact Tony DeCrappeo of the COGR staff at (202) 289-6655.

## PLEASE READ THIS BEFORE YOU USE DATA WITHIN

September 2001

This is a compilation of facilities and administrative costs rate components provided by most COGR member universities. The 1999-2000 questionnaire to which the members responded is contained in Appendix 5. The compilation covers responses for the five year period 1996 through 2000. The fifth year respondents totaled 136, from 116 of the 142 member COGR institutions. The responses received may be from campus offices, system offices or branch campuses under the aegis of centralized state boards of higher education. Because the system or state board may hold COGR membership, as opposed to individual campus membership, the number of possible respondents is greater than the number of COGR members, however, information is not duplicated. Respondents included 47 universities providing 96% of the research expenditures of the 50 largest institutions, and those providing 90% of expenditures of the 100 largest, as reported in the 1999 NSF survey.

The data are provided in hard copy and on a computer diskette both in spreadsheet format (QuattroPro, Lotus, and Excel) and as a Paradox database. The compilation displays components of facilities and administrative costs rates, both negotiated and proposed. It also displays percentages of adjustment for carryforward or administrative cap, the respondents using depreciation or use allowance or both, student population, type of rate, cognizant agency, institutional operating expenses, research volume, and which universities are using special cost analysis studies. This year for the first time the report contains data on space for the principal institutional functions, as well as rates negotiated for future years. Individual universities are identified. Also included are data on the federal MTDC base and on facilities and administrative costs recovery from federal awards. A few graphs of averages and distributions of 1999-2000 rates are part of the compilation. A chart comparing average rates over the past eight years is also shown.

The data presented are as reported by the respondents, with one significant exception. In several cases, a breakout of the negotiated administrative rate into separate components was not available. In these cases, if the individual components of the proposed administrative rate were provided, then the negotiated administrative rate was apportioned among its components in the ratio as in the proposed rate. In the six cases where a breakout of the proposed rate was not available, nothing is reported for the components of the administrative rate. Except for this circumstance, blanks in the rate section are to be interpreted as either zeroes or else that this contribution is included in another related item. The latter is especially true in the case of utility costs, which are frequently not separated out from the rest of operations and maintenance costs. Elsewhere in the table, blanks in numerical items denote the unavailability of data. In particular, two institutions were unable to provide the MTDC, and their rates had to be excluded from the averages.

You are cautioned not to look for more information than what is purported to be represented here. This compilation lists and compiles information from various respondents, but it does not contain any analyses other than those of gross rate data, nor do the data hold rationale for why certain costs are included in one pool as opposed to another.

Differences in facilities and administrative costs rates at colleges and universities are attributable to differences in space related costs, in institutional cost recovery policies, the content of the modified total direct cost research base and other factors including differences in administrative costs. Comparison of rates among universities without the knowledge of the factors leading to these differences is therefore discouraged.

## **COMMENTS ON ANALYSES OF THE DATA**

This section provides a limited amount of data on various averages of negotiated rates and their components. In all cases, the averages are obtained by weighting the rate by the MTDC of the unit. As indicated in the introduction to this database, in eleven cases components of the negotiated administrative rate were not available. Therefore, component averages of the administrative rate excluded these schools, although they were included in averages of the total administrative rate. Thus the individual components will not sum to the average of the total administrative rate.

Many respondents were unable to separate utility costs from other O&M costs. For this reason, no attempt was made to provide any separate average of the contribution of utility costs to the facilities rate. Likewise, no attempt has been made here to correlate the magnitude of a rate component with the use of special studies. Instructions requested that a special study be reported only if it contributed to the determination of the negotiated rate. There is a degree of subjectivity in this definition. Furthermore, special studies may range from a complete cost analysis to the use of a non-standard allocation procedure.

In comparing averages of the 1999-2000 data with previous years, it must be remembered that the particular universities represented may differ slightly from year to year, although there is a great deal of consistency in representation in the database. In principle (but not necessarily), the presence or absence of one or two universities with appreciable MTDC base, and with rates which differ appreciably from the mean, could affect the average significantly, especially when considering only private or only public universities. To avoid this effect, a chart is also given comparing 1999-2000 components with those for 1998-99, for the 116 units which participated in the survey both years. The consistency in rates from 98-99 to 99-2000 is striking, viz., an increase of only 0.16 points in the total rate. If all respondents are included for each year, the average total rate increases by only 0.17.

The cautions given in the introduction regarding comparisons among universities must be repeated here. Differences may be attributed to differences in actual costs, institutional policies, the magnitude and content of the MTDC base, and other university-specific factors. Differences in space-related costs can be summed up by pointing out differences in: (1) facility size and intensity of use; (2) amount of debt; (3) depreciation vs. use allowance; (4) size of research base relative to investment in buildings and facilities; (5) utility rates; (6) geographic location; and (7) mix of research. Differences in administrative costs are principally differences that result from a university's cost recovery policies and practices. These are driven by several factors including pressure from faculty to price research, and whether an institution is public or private. Rates also vary because the percentage of costs which benefit research, as opposed to instruction, is subjective and, therefore, differently allocated from university to university.

Although data on research space were collected this year for the first time and are included in the tables and database, no attempt has been made to use these data for analyses of facility size or intensity of use.





## Average Points in Facil. and Admin.





## Avg. Component Pts. - Facilities





## Avg. Component Pts. - Administration





## Fraction of Total Project Costs




# DISTRIBUTION OF 1999-2000 RATES
